Sir / Madam,

In pursuance of memo no. 3(Camp-at)-BCW dt. 20.05.2021 of BCW Department & I/133696/2021 dt. 18.05.2021 of TD Department, this is to inform you that it has been decided that OASIS portal for verification of Pre-Matric & Post Matric Scholarship applications for the year 2020-21 will be opened with the following conditions:

- a) The portal will be opened from 01.06.2021 to 11.06.2021 for this purpose and the verification needs to be completed within this specific time frame.
- b) Verification will be taken up for those applications only in regard to which all the documents have either been deposited or online approval from the institutions have been received by the appropriate authority till 31.03.2021 midnight and finally.
- c) Verification will be taken up for only those types of scholarships for which LoC principle is applicable.

PO-cum-DWO of the districts and DWO & ex-officio Jt. Director Kolkata are requested to strictly adhere to the second condition as mentioned above to avoid chaotic situation.
