Sub: Key points for implementation and monitoring of projects under Comp-6 & 11 of RUSA-2.0

Madam/Sir,


As fund has been sanctioned for your Institution under concerned component of RUSA-2.0 (Annexure-A), I am directed to emphasize the following key points in implementation and monitoring of project under RUSA-2.0 :-

1. The Institution authority should open a dedicated RUSA account in a scheduled Nationalised Bank and send the details to the Directorate of RUSA (in Mandate Form attached to this letter). No funds other than RUSA should be kept in the RUSA bank account.
2. The College authority will have to form a Project Monitoring Unit (PMU) with appropriate representatives from academic officials of the institution, faculty, senior administrative officers, technical support staff and students. The Unit headed by the Head of the Institution will be responsible for the monitoring of the project at the institutional level.
3. After opening Bank Account the Authority of the Institution should come to the office of the directorate of RUSA for registration on PFMS (Public Financial Management System) when asked for by this office.
4. All expenditures have to be made as per existing guidelines of Finance Department, Govt. of WB and as per directives of RUSA.

This may be treated as extremely urgent.
