- (ii) The certificate of OBC/SC/ST category should not be more than one year old (Certification Issued by OBC/SC/ST certificate board before 30 January 2019, must produce original/verified certificate before the Technical Staffing Desk of the Range Recruitment Board (available to be used for verification/correction) OBC/SC/ST certificate and furnish an undertaking in prescribed pattern to be provided by the Range Recruitment Board stating that he would submit the same copy to the desk of his certificate if awarded interview or direct admission in certificate on basis of which he claims his caste/tribe/category, even if found to be false/incorrect.
- (iii) Any one of the following documents in order to prove its validity:
 - (a) Matriculation (or) PMA Card (or) Passport (or) Driving License and (or) OMC (Passport photo).

Candidate must produce supporting documents against their claim to change their caste category (i.e. original last certificate/valid certificate of caste/creed/community/tribe issued by the competent authority in Service of Police present date).
